147 MILLION ORPHANS PARTNERSHIP PROGRAM

As a part of our fundraising program, families can also sign up for our partnership program. This program allows you to have a direct web link to our site so your supporters can purchase gear that is directly credited toward your adoption! You can allow the supporter to order and ship directly to themselves, eliminating the need for you to place bulk orders. Here's how it works:

1. You receive a direct web link to 147 Million Orphans that you can place on your blog or give to your supporters.
2. Your supporters click that link and purchase the gear. You will receive credit for 30% of any purchases of any gear that is a part of the fundraising program. Only approved fundraising products are credited toward your totals, not necessarily all items purchased by a supporter.
3. These proceeds will be paid directly to the agency or 501(c)(3) that you are partnering with for adoption. Due to tax laws, we cannot pay these proceeds directly to you...they must be paid to an agency or non-profit. Payments are made quarterly.

The Partnership Program is great for a fundraising family that has a lot of supporters around the country. This allows you to do the bulk of your fundraising through emails, a blog link, or social media. To sign up for the Partnership Program, simply read the program terms and conditions page. After agreeing to the terms, complete our application. Once approved, we will email your fundraising link to you and you can start selling!

PARTNERSHIP PROGRAM TERMS AND CONDITIONS

1. Every partner must complete an application to be considered for the program. You must be actively adopting through an agency or non-profit to be a partner in this program. The agency's name, address, tax-id, and preferred contact must be included on the application.
2. You will then be given a unique code that allows individuals to link to our website. You are allowed to send that link to your supporters, who in turn will order gear from our site. You may distribute this code in an ethical manner and in compliance with all laws and rules that govern email marketing and anti-spam.
3. Any orders that are placed using your unique link to our website will be considered for payment. 30% of gear purchased will be eligible for payment. If an supporter neglects to use your unique code and orders directly for the website, we cannot give credit for that sale to your account. They **MUST** use your link in order for you to receive credit. There are no exceptions to this rule.
4. All commissions earned under the partnership program are paid directly to an agency or a 501(c)(3). They will be paid 30 days after the end of each quarter for sales from that quarter: January 31, April 30, July 31, and October 31. No commissions will be paid to individuals.
5. A partner must reach a minimum commission amount of \$100 for a payout to occur. This minimum threshold must be met for each payment made to an agency. If a partner does not reach the \$100 threshold at any time during their 12 month fundraising period, they will forfeit commissions. If a partner earns commissions and 147 Million Orphans is unable to confirm your association with an agency, commissions will be forfeited and become the property of 147 Million Orphans.
6. Either the partner of 147 Million Orphans may terminate this program at any time. We reserve the right to change, modify or terminate the partnership program. We cannot be held liable for any damages in connection with this program. No express or implied warranties or representations are made in connection with this program.
7. A partner's approval may be revoked or suspended for any reason that 147 Million Orphans deems necessary.

8. The terms of this agreement will last for 12 months of fundraising.
